Further to Bruce's visit yesterday, the flint wall is in reasonable condition with just a few flints that have popped out which can be put back in easily enough.

The coping bricks on the wall are also not too bad but could certainly benefit from repointing with the possibility of some loose ones being removed and reseated. We would use a traditional hot lime mix and our rate would be £480 + VAT per day plus materials used.

It is quite difficult to estimate how long the work would take as all the growth and lichen moss etc will need to be cleaned off prior to the preparation of the repointing work.

We hope this is acceptable to you and look forward to hearing from you.

Hi Sarah,

As you are aware this is a temporary TRO (TTRO) to reduce the speed limit due to works being undertaken to assist with construction of the windfarm projects and is to keep the public and workers safe due to road widths, road speeds, and heavy plant crossing the carriageways between parcels of land.

Once the windfarm projects are completed, the TTRO will end.

If you wish to see the speed reductions become permanent, this will have to follow the same process as all other speed reduction TROs. There would need to be a feasibility study to determine whether the speed reductions meet NCC's Speed Strategy. We need to remember that the reasons for the speed reductions are different, one is for the safety of all road users due to construction works and is likely to be required under the DCO (Development Consent Order) which means that legally it will have to be removed at some point, and the one that you are proposing is for a general speed reduction to slow traffic in the village of Cawston and you will be looking for this to be permanent forever more.

A feasibility study will cost approximately £5k, and if supported by the Member and all other stakeholders will take between 12-18months to get through the legal process. This is likely to cost between £15-£25k to deliver due to the amount of work required, including signage. This cost will need to be funded by the PC/Member.

If the PC wish to progress with this, you will need to speak with your Highway Engineer, Richard to get the ball rolling. It is likely though that the feasibility study will need to occur after the DCO comes to an end as the Network Safety team will need to use data collated when the speed limits are at their existing levels, and not when the reduced TTRO reduced levels are in place.

Cawston Cemetery – Site Investigation Quotations Comparison Report

Purpose

The Parish Council invited five companies to quote to undertake a geotechnical site investigation at the proposed cemetery extension. However, only two companies have provided quotes. The primary objective is to determine the presence or absence of groundwater beneath the site to support planning and environmental compliance.

Summary of Quotations

Comparison and Evaluation

- Quote A offers a more comprehensive investigation, with deeper boreholes (6 m vs 5 m), groundwater monitoring in all three locations, and four separate monitoring visits to assess seasonal variation.
- Quote B is a basic initial assessment, with fewer boreholes fitted with monitoring pipes and only a single return visit. It provides a technical note rather than a full factual report.
- Quote A specifically references British Standards and Government Guidance, ensuring compliance with burial ground regulations.
- Quote B does not cite any standards, though the proposed work would likely be compliant with general geotechnical practice.
- Quote B's shorter monitoring period would produce a faster but less detailed result.
- Quote A is approximately £1,654 more expensive but includes four times as many monitoring visits and a fuller report.
- Quote B is significantly cheaper but covers a reduced scope that may not fully satisfy Environment Agency guidance for cemetery extensions.
- Quote A explicitly warns that further works may be required if conditions are variable but provides a robust baseline study.
- Quote B may need additional visits or monitoring later, increasing cost and time if regulators require more data.

Conclusion

Both quotations address the same objective—assessing groundwater conditions—but they differ markedly in depth, duration, and deliverables. Quote A provides a comprehensive and regulation-aligned investigation, suitable for long-term assurance and Environment Agency scrutiny. Quote B offers a lower-cost, limited-scope option appropriate for preliminary understanding but may not provide sufficient evidence for planning or burial ground licensing.

Recommendation

If the Parish Council's priority is to ensure full compliance with groundwater protection guidance and to avoid the need for repeat investigations, Quote A represents the more robust and defensible approach.

If budget constraints are significant and only a basic initial assessment is required, Quote B could be accepted on the understanding that further monitoring may later be necessary, potentially increasing total costs.
